## PRIVACY AND DATA PROTECTION

West of England Combined Authority is the data controller for the purposes of the Data Protection Act 2018 and other regulations including the UK General Data Protection Regulation (UK GDPR), which means it determines what your personal data is used for and why it is collected.

The purpose of this privacy notice is to tell you about how we collect and use personal data in connection with our service. We may update this privacy notice from time to time.

This website uses HTTPS protocol which consists of a communication over Hypertext Transfer Protocol (HTTP) within an encrypted connection, protecting against man-in-the-middle attacks. You can find more information on Wikipedia.

#### WHAT PERSONAL DATA DO WE NEED TO COLLECT AND USE?

We expect to collect mostly data related to bus services which can be made publicly available.

However, in certain circumstances we may hold certain personal information, if users choose to, such as:

- First and last name of contacts at certain organisations
- Personal email addresses and phone numbers

We discourage any users from choosing to use personal contact details as main point of contact. However, we will not share publicly any names, phone numbers or email address, and these will only be accessible to us via the system.

Our website may contain links to other 3rd party websites. The information practices or the content of such other websites is governed by the privacy statements of such other websites. We encourage you to review the privacy statements of other websites to understand their information practices.

# **HOW DO WE USE YOUR PERSONAL INFORMATION?**

We don't share your personal data with any other organisation or individual unless you give your express consent, unless there is a lawful requirement to do so. All information collected is processed in accordance with the principles of the Data Protection Act 2018 and the UK GDPR.

We will use any personal information provided via the website for the sole purpose of contacting you relating to your application(s). In this case the processing is necessary for us to perform a task in the public interest or for our official functions as the transport authorities in the region.

No personal information is routinely sent or held outside the UK. Should the transfer of personal information outside the UK become necessary, it will only take place if permitted by law, and then only where there are appropriate safeguards in place to protect the data.

#### WHAT OTHER DATA DO WE COLLECT AND USE?

To fully process your application, we will collect varied information relating to your bus services.

Some of this information may need to be shared with partners, including local authorities, to successfully process the application.

Any applications that have been received, approved or rejected will be made publicly available online at Travelwest.info/Registrations as is required of us as the Bus Registrations Authority for the West of England.

We may also share this data as a result of a Freedom Of Information request.

# HOW LONG WILL WE KEEP YOUR PERSONAL INFORMATION?

It is a lawful requirement that we keep a record of all bus registrations for 3 years from the moment they are cancelled.

Therefore, all contact details associated with any such records will remain within our records for the same period unless you choose to change this.

# YOUR RIGHT AS A DATA SUBJECT

The law gives you a number of rights to control what and how personal information is used by us, including the right to access a copy of your personal information and withdraw your consent when we rely on your permission to use your personal data.

However, we will be required to keep on record the public information regarding the bus operator for 3 years from the moment their last bus service is cancelled.
